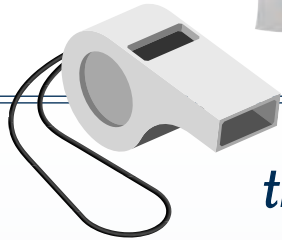

LJB's Cookin' Corner

GARLIC PARMESAN CRUSTED SALMON & ASPARAGUS

INGREDIENTS

- 1.5 lb salmon (3-4 salmon fillets)
- 1 lb asparagus, ends trimmed
- ¼ tsp. salt
- ¼ tsp. pepper
- 3 tbsp. olive oil
- 6 garlic cloves, minced
- 1 cup Parmesan cheese, shredded
- ¼ cup fresh parsley, chopped

INSTRUCTIONS

1. Preheat oven to 400 degrees. Line a baking sheet with parchment paper. (Be sure the parchment paper packaging says that it's safe to use at 400 degrees.)

2. Pat salmon dry. Brush with 2 tablespoons of olive oil on all sides. Season with salt and pepper. Place the salmon, skin side down, on a parchment paper-lined baking sheet. Coat asparagus with olive oil, season with salt and pepper, and place around salmon on a baking sheet.
3. Spread minced garlic on top of the salmon and asparagus. Top with grated Parmesan cheese.
4. Bake the salmon in the preheated oven for 15 to 20 minutes.
5. Remove from the oven. Top with chopped fresh parsley before serving.

world. Improv exercises also involve active listening, which is important for effective communication with colleagues and clients. Additionally, we can build trust and team cohesion. As an added bonus, we're having a lot of fun with it.

At our last class, we did a warm-up exercise called Mind Meld that is not just great for team building but would also be fun for long car trips. The team stood in a circle. The first two people pounded their fists on their palms (as if you are starting a game of rock-paper-scissors). The first person says, "One," then the second person says, "Two". They together say, "Three," and then yell out a random word. It can be any common word but not a proper noun.

Our first words were, "Rocket!" and, "Soda!" The second person in that group turns to the next person to their right, and they repeat the exercise. However, instead of yelling a random word, they each try to say a word that is the perfect word in between the two previous words. If your partner says, "One,"

and you don't have an idea of what to say yet, wait to say, "Two" until you have your word. Both people must say a word at the same time after "three."

The game continues around the circle. There is no right word or wrong word. Just words that match or words that don't yet match. The only rule is that you cannot repeat a word that was already said.

Hopefully, the divide between the words gets smaller each time until finally, two people shout the same perfect middle word. The first time doing this exercise, we found the perfect middle word between "rocket" and "soda" to be "cake" on just the fourth pairing, a record that we were not able to accomplish again.

With this game, we were actively listening to the group, hearing their information, and processing it.

We were connecting with the team, accepting their ideas, and building on them together with our ideas. Pretty good stuff for a fun, warm-up game!
