HONEY GARLIC SHRIMP

A few days later, Indya appeared in my office with a bag and said, "Someone just dropped this off for you; they didn't leave a name." I opened the bag, and inside were a few containers of fresh honey. I knew it had to be the only person I know who keeps a few hives in our community. Fresh honey is great! Fresh honey adds a little something extra to this dish, which my family loves. Try this quick and delicious recipe with fresh honey from your local beekeeper.

INGREDIENTS

- I lb. shrimp, peeled and deveined
- I tsp. garlic, minced
- ¹/₂ tsp. ginger, minced

- 4 tbsp fresh honey
- 2 tbsp soy sauce
- Optional: Rice or pasta

DIRECTIONS

- Combine the garlic, ginger, honey and soy sauce and set aside.
- Over medium high heat, sear the shrimp in olive oil until a little brown on both sides and pink throughout.
- When shrimp are almost cooked, pour the sauce over top and heat for a few minutes longer.
- 4. Optional: Serve over cooked rice or cooked pasta. I like to pour the entire skillet into a pot of cooked pasta and toss to get an even coverage over the pasta.
- 5. Serve and enjoy!


REVIEW ROUNDUP
