

INGREDIENTS

- 4 tbsp salted butter
- 2 boneless chicken breasts, cut into pieces
- 8oz andouille sausage, cubed
- 8oz smoked sausage, cubed
- 1 bell pepper, sliced
- 1 onion, sliced
- ½ cup green onions, sliced
- 1 tbsp Tony Chachere's Original Creole seasoning
- 9oz Heinz Homestyle Savory Beef Gravy
- 12oz Bertolli Vineyard Marinara with Merlot Wine
- 16oz Penne Pasta

DIRECTIONS

1. Boil pasta according to directions and set aside.
2. In a pre-heated skillet on medium-high, add butter



and the cubed sausage.

3. Sauté for 2 minutes and remove sausage.
4. Add chicken pieces to skillet and sauté for 3 minutes.
5. Add bell pepper, onion and green onions. Sauté a few minutes until soft.
6. Add sausage back into skillet.
7. Add gravy and marinara. Bring to a boil and cook for 10 minutes covered on medium.
8. Turn off fire.
9. Add pasta. Mix well and let sit to cool for a few minutes.
10. Enjoy!

have “the government validate their relationship.” She wanted to know if she had a wrongful death case.

The U.S. Census reports about twice as many people live in a long-term relationship than did so 10 years ago, and they expect the numbers to continue rising. Stacy’s question brings up an interesting point worth considering for all long-term unmarried couples.

Louisiana law contains specific provisions for wrongful death cases. This provision specifies very clearly the classes of people entitled to bring a lawsuit for wrongful death.

The classes are:

1. Spouse and/or children.
2. If no spouse and/or children, parents.
3. If no spouse, children and/or parents, surviving siblings.
4. If no spouse, children, parents

and/or siblings, surviving grandparents.

In addition to the above people, in a survival action – which is a case brought to recover the damages of the deceased person – if none of the prior people survive or exist, a succession representative may bring a claim. Which opens up another can of worms...

For Stacy, unfortunately, Mike’s parents were still living. Although they did not have the best relationship with Mike over the past 10 years, under Louisiana law, they were the only people who could recover for the loss of Mike.

This was truly a heartbreaking conversation to have, and answer to give, to a loved one.
